## **SPEAKER BIOGRAPHIES**

### **Natasha Willson, LifeWire**

Natasha Willson is an advocate at LifeWire (formerly Eastside Domestic Violence Program). She provides legal information and resources, including assistance with protection orders, to survivors of domestic violence from North and East King County. Natasha also coordinates legal clinics for survivors and participates in legal advocacy training for domestic violence advocates, attorneys, and volunteers. Prior to working at LifeWire, Natasha worked at Catholic Immigration Legal Services as an Immigration Case Manager. She was a Board of Immigration Appeals Certified Representative, assisting refugees and immigrants with a variety of immigration needs, including VAWA cases. Natasha holds an M.Sc. in Applied Math and previously worked in IT.

### **Zeshan Khan, Law Office of Zeshan Q. Khan PLLC**

Zeshan Q. Khan grew up touring the East Coast, from New York to North Carolina to Florida to Georgia. He attended college at the University of Florida. Zeshan relocated to Chicago for law school, graduating from the Chicago-Kent College of Law. He then went on to receive his Masters in Law in Sustaining International Development at the University of Washington, School of Law. Zeshan is a member of both the Illinois and Washington State Bars, and is a member of the Family Law and Bankruptcy Law sections through the Washington State Bar. He had the opportunity to clerk for the Honorable Sen K. Tan in Alaska before moving back to Seattle to establish his practice. His current practice emphasizes bankruptcy, family law, and general litigation, including personal injury, small business, and real estate litigation.
